- 1. BINDING AGREEMENT. In order to enter the Minus K Technology Isolator Giveaway ("Contest"), you must agree to these Terms and Conditions ("Terms"). Therefore, please read these Terms prior to entry to ensure you understand and agree. You agree that submission of an entry in the Contest by completing and delivering the Submission Form constitutes agreement to these Terms. You may not submit an entry to the Contest and are not eligible to receive any prize unless you agree to these Terms. This Contest is open to departments of colleges and universities within the United States, that have an AFM, Electron Microscope, Interferometer, Laser Optical System, Micro Hardness Tester, or any other special equipment that would benefit from a low-frequency vibration isolator.
